

*The Jewell City Council met in a Regular Session March 22, 2021, at the Jewell City Hall starting at 7:00 p.m. Mayor Reiter called the meeting to order with Council Members: Outzen, Lorenzen, Winborn and Young present. Roethler arrived at 7:16 p.m.*

**APPROVE MINUTES OF MARCH 8, 2021, REGULAR SESSION:**

*Winborn made a motion to approve the minutes of March 8, 2021, Regular Session.*

*Outzen seconded the motion. Roll Call 4 – 0. Motion carried.*

**CONSENT AGENDA:** a) Addition to agenda, b) Claims

*With no addition to the consent agenda, Outzen made a motion to approve the consent agenda.*

*Winborn seconded the motion. Roll Call 4 – 0. Motion carried.*

**EMPLOYEE – UTILITY BILLING CLERK:** *Winborn made a motion to offer the position to Mellissa Roethler at a rate of \$15.00 per hour. Lorenzen seconded the motion. Roll Call 4 – 0. Motion carried.*

**CENTRAL IOWA RECOVERY, INC:** *Young made a motion to approve a \$500.00 donation to Central Iowa Recovery, Inc. in Webster City. The funds will be used for the Serenity Garden Project. Outzen seconded the motion. Roll Call 5 – 0. Motion carried.*

**2021-2022 BUDGET:**

*a. At 7:30 p.m., Outzen made a motion to open the public hearing regarding the 2021-2022 City of Jewell Operating Budget. Roethler seconded the motion. Roll Call 5 – 0. Motion carried. At 7:35 p.m., with no public input, Winborn made a motion to close the public hearing. Roethler seconded the motion. Roll Call 5 – 0. Motion carried.*

*b. Outzen made a motion to approve Resolution 21-09 pertaining to the annual budget for fiscal year July 1, 2021 to June 30, 2022 as set forth in the Budget Summary Certificate and the detailed budget in support thereof showing the revenue estimates in the amount of \$1,383,789.00 and appropriation expenditures in the amount of \$1,301,017.00 and allocation to programs as follows: The Library will receive \$59,051.00 from the general fund and \$10,862.00 from the special levy. JADE will receive \$30,000.00. The following salaries for the 2021-2022 fiscal year were approved: Bernie Bell \$63,668.80 with \$5,000.00 additional compensation; Cathy Siefken \$41,600.00 with \$4,000.00 additional compensation; Dave Osmundson \$38,646.40 with \$8,197.80 non-taxable health insurance benefit; David Turpen \$63,003.20 with \$18,172.56 non-taxable health insurance benefit; and Kaleb Morton \$49,088.00 with \$7,317.36 non-taxable health insurance benefit, and activities for said fiscal year are adopted as summarized. Young seconded the motion. Roll Call 5 – 0. Motion carried.*

**YOUTH BASEBALL FUNDING REQUEST:** *Eric Young requested \$500.00 in funding for the 2021 youth baseball season. Winborn made a motion to approve the funding request. Lorenzen seconded the request. Roll Call 4 – 0, with Young abstaining. Motion carried.*

**SHOMO-MADSEN-KRAUSE:** *Melissa Kelley reviewed with the City Council the proposed yearly insurance renewal premiums. She will review the current equipment items for the street department with Public Works Director Bernie Bell and increase the amount for the new baseball field lights. The final premiums will be reviewed at a future city council meeting. No action was taken at this time.*

**PARKING ORDINANCE:** *The City Council, City Attorney Deppe and Police Chief Turpen discussed changes to the existing parking ordinance for the City of Jewell. Young made a motion to table the discussion. Outzen seconded the motion. Roll Call 5 – 0. Motion carried.*

**THIRD READING OF ORDINANCE 287, AMENDING CHAPTER 15, MAYOR COMPENSATION:** *Outzen made a motion to approve the third reading of Ordinance 287, amending Chapter 15, Mayor Compensation. Effective January 1, 2022, the salary of the Mayor shall be \$2,500.00 per year, payable quarterly. Young seconded the motion. Roll Call 4 – 1, with Roethler voting nay. Motion carried.*

**THIRD READING OF ORDINANCE 288, AMENDING CHAPTER 17, COUNCIL COMPENSATION:** *Young made a motion to approve the third reading of Ordinance 288, amending Chapter 17, Council Compensation. Effective January 1, 2022, the salary of each Council Member shall be \$50.00 for each meeting of the Council attended, payable quarterly. Outzen seconded the motion. Roll Call 4 – 1, with Roethler voting nay. Motion carried.*

**CITY PARK FLOWERS:** *A thank you card was signed and mailed to Don and Doris Rastetter for their years of service to the City of Jewell. They have planted and maintained the Jewell Park flowers for ten years.*

**ADJOURN:** *Winborn made a motion to adjourn the meeting. Young seconded the motion. The meeting was adjourned at 8:22 p.m.*
