

The Jewell City Council met in Regular Session Monday, August 9, 2021, at the Jewell City Hall starting at 7:00 p.m. Mayor Reiter called the meeting to order with Council Members: Outzen, Roethler, Lorenzen and Winborn present. Absent – Young.

**APPROVE MINUTES OF JULY 26, 2021, REGULAR SESSION:** Outzen made a motion to approve the minutes of July 26, 2021, Regular Session. Winborn seconded the motion. Roll Call 4 – 0. Motion carried.

**THIRD/FINAL READING OF ORDINANCE 292 / GOLF CARTS, ATV, OHV/UTV:**  
Winborn made a motion to approve the third reading of Ordinance 292, amending and replacing Chapter 75 all-terrain vehicles, snowmobiles and golf carts. Outzen seconded the motion. Roll Call 4 – 0. Motion carried.

**EMERALD ASH BORE TREE REMOVAL QUOTES:** Winborn made a motion to approve the quote from Robb’s Tree and Stump Service of \$650.00 per tree. Roethler seconded the motion. Roll Call 4 – 0. Motion carried. Nine trees will be removed this fall and more trees will be budgeted for removal next year.

**HAGEN WATTS MEMORIAL BENCH REQUEST:** Tom Watts removed his request from the agenda. No action was taken.

**MANDY GROTEWOLD – MURAL:** The City Council gave Mandy Grotewold approval to work with Jewell – A Main Street Community to design and install a mural in city limits. No funds will be required from the City of Jewell.

**MAIN STREET IMPROVEMENT PROJECT / NATHAN SUMMERS WITH D.A. DAVIDSON & CO.:** Nathan Summers was present to review with the City Council options to fund the proposed Main Street Improvement Project. No action was taken.

**AMERICAN RESCUE PLAN ACT / DETERMINATION OF FUNDING REQUEST:** The City of Jewell received a determination of funding report stating the City of Jewell will be receive funding in the amount of \$169,737.95 in ARPA NEU Funding. Half of the funds will be received this year and the remaining balance in the Spring of 2022.

**617 MAIN STREET:** No action was taken.

**CITY PARK PLAYGROUND:** Winborn made a motion to approve the additional \$250.00 for mulch at the City Park. Roethler seconded the motion. Roll Call 4 – 0. Motion carried.

**JEWELL GOLF AND COUNTRY CLUB LIQUOR LICENSE:** Outzen made a motion to approve the renewal of the Jewell Golf and Country Club's liquor license. Roethler seconded the motion. Roll Call 4 – 0. Motion carried.

**BUYIT.IOWA.GOV LAPTOP ORDER #000-424:** The State of Iowa offered group purchases of laptops using CARES Act funds to each city not to exceed \$9,500.00. An order was placed to purchase five laptops and one camera. The laptops will be used to update the Police Department, Fire Department, Water Plant and City Hall technology.

**PUBLIC INPUT:** Linda Erickson was present to discuss her concerns with the property at 448 East Lane. Mayor Reiter and Police Chief Turpen will visit with the homeowner to determine what fences she has received permits for and to confirm that the vehicles are operational.

**2021 CITY ELECTION:** Election documents were handed out to Mayor Reiter, Councilperson Outzen and Councilperson Winborn. Councilperson Young will not be running again. If you want information about running for Mayor or City Council positions, please stop by City Hall. The first day candidates can file is Monday, August 23, 2021. The last day for candidates to file is Thursday, September 16, 2021 at 5:00p.m. at Jewell City Hall.
