**CITY CLERK / IOWA CERTIFIED MUNICIPAL CLERK DESIGNATION:** *City Clerk Cathy Siefken completed the required courses and received the Iowa Certified Municipal Clerk certification. The City Council had previously discussed and approved a \$2.00/hour raise in recognition of her obtaining the certification. Winborn made a motion to implement the raise. Outzen seconded the motion. Roll Call 4 – 0. Motion carried.*

**JEWELL–A MAIN STREET COMMUNITY/615-617 MAIN STREET PURCHASE OFFER:** *Winborn made a motion to reject the purchase offer of \$7,000.00 from the Jewell – A Main Street Community organization. Lorenzen seconded the motion. Roll Call 3 – 0, with Outzen abstaining. Motion carried.*

**RESOLUTION 21-14:** *Young made a motion to approve Resolution 21-14, approving the appointment of Kaleb Morton to the Jewell Fire and Rescue Department. Winborn seconded the motion. Roll Call 4 – 0. Motion carried.*

**JEWELL CENTENNIAL COMMITTEE:** *The Jewell Centennial Committee was present to discuss the possibility of dissolving the organization. Mayor Reiter will instruct City Attorney Deppe to work with the Committee to determine the necessary steps to dissolve the organization and inform the City Council of the process.*

**TEAM IOWA SNOWMOBILER'S ROUTE REQUEST:** *Winborn made a motion to approve the route request through the City of Jewell from Team Iowa Snowmobiler's. Young seconded the motion. Roll Call 4 – 0. Motion carried. The approved route is the same as previous years.*
