- **b.** Code of Ordinances, Chapter 106, Collection of Solid Waste The City Council and City Attorney Deppe reviewed the ordinance for possible changes that would allow another collector to operate in Jewell.
- c. Collector's license application American Sanitation, LLC, Owner Brad Schmidt was present to discuss his application to obtain a solid waste collector's license from the City of Jewell. He

answered questions to clarify his fees and cart sizes. Outzen made a motion to table the discussion until the January 10, 2022 city council meeting. Roethler seconded the motion. Roll Call 3-0. Motion carried.

JEWELL FIRE AND RESCUE:

HAMILTON COUNTY SHERIFF'S 2022-2023 INCREASES PATROL RATE: Due to increased operating costs, the Hamilton County Sheriff's office will be raising their per capita charge from \$10.00 to \$14.00 effective July 1, 2022.

ENHANCE HAMILTON COUNTY SEED CATALYST GRANT FOR EJS POLICE DEPT:

Police Chief Turpen would like to apply for a grant from Enhance Hamilton County. The funds would be used to update the police department's firearms. He asked for approval to apply for the grant and have the City Clerk's of Ellsworth, Stanhope and Jewell be the fiscal sponsors on the grant application. Roethler made a motion to approve the grant application and fiscal sponsors. Winborn seconded the motion. Roll Call 3-0. Motion carried.

NEW 28E AGREEMENT FOR EJS POLICE DEPARTMENT: Winborn made a motion to approve the new 28E Agreement for the EJS Police Department. Outzen seconded the motion. Roll Call 3-0. Motion carried.

RESOLUTION 21-17, APPOINTING THE NEW EJS POLICE BOARD REPRESENTATIVES: No action was taken.

WATER AND WATERWATER OPERATOR CERTIFICATION PROGRAM AFFIDAVIT:

The Iowa Department of Natural Resources has approved the Water and Wastewater Operator Certification Program Affidavit. The City of Jewell has received a Certificate of Insurance from ISG, Inc., providing insurance coverage for Jason Loots, the Water/Wastewater Operator that will be working with Public Works Technician Trevor Swenson.
