The purpose of conducting the survey is to see if we qualify as a city for eligible grants in an effort to keep next year's property taxes from increasing due to an upcoming lagoon project. Council members or city employees will be working to get the survey done in the month of June.

**COUNCIL MEMBER LOYAL WINBORN RESIGNATION:** Butler made a motion to accept councilmember Winborn's resignation. Rohloff seconded the motion. Roll Call 4—0. Motion carried. The city would like to express their sincere thanks to Loyal for his years of service to the city of Jewell.
